ORDER TO CERTIFY RECORD	

This matter comes before the Court on Plaintiffs' Motion to Certify Record pursuant to CRCP 106(4)(a)(III), which states:

CRCP 106 (a) (4) (III) If the complaint is accompanied by a motion and proposed order requiring certification of a record, the court shall order the defendant or officer file with the clerk on a specified date, the record or such portion or transcript thereof as is identified in the order, together with a certificate of authenticity. The date for filing record shall be after the date upon which an answer to the complaint must be filed.


The Court directs the Defendant, Debra Johnson, in her capacity as Clerk and Recorder of the City and County of Denver, to certify to the Court, on or before July 29, 2013, the record of proceedings before the Clerk and Recorder involving the referendum petition filed on July 1, 2013 by the above Plaintiffs. The record shall be accompanied by a certificate of authenticity. The record shall include the following:

2. Exhibit 2 Denver Ordinance number 168, series of 2013.
3. Denver Ordinance number 170, series of 2013.
4. Proposed form of referendum petition, affidavit of petitioners committee, and ballot issue submitted by Petitioners Committee May 13, 2013

5. Letter of Clerk and Recorder mailed to Petitioners Committee May 17, 2013.
6. Letter of counsel for Petitioners Committee to Clerk and Recorder dated May 20, 2013.
7. Revised form of referendum petition, affidavit of petitioners committee, and ballot issue filed with Clerk and Recorder May 20, 2013.
8. Letter of Clerk and Recorder to Petitioners Committee dated May 22, 2013.
9. Letter to Clerk and Recorder from petitioners Committee dated July 1, 2013.
10. List of petition sections filed with Clerk and Recorder July 1, 2013.
11. Original signed and notarized referendum petition consisting of 120 petition sections filed with the Clerk and recorder July 1, 2013.
12. Letter of Clerk and Recorder to Petitioners Committee dated July 3, 2013 rejecting referendum petition.
13. Any other documents deemed part of the record by the Clerk and Recorder.
